

**SUBJECT:** Competitive Sealed Proposal (CSP) #23-05 for the 2019 Bond Program, Phase III-Bid Package 8, Project 1, Playground Renovation and Improvements – Foundations and Earthwork Project

The District approved renovation and improvements for District-wide elementary school playgrounds as a part of the 2019 Bond program. Additionally, the Board of Trustees approved Glenn Engineering as the design professional and approved Competitive Sealed Proposal as the method of procurement for the project.

The 2019 Bond Program Phase III Playground Renovation and Improvements package includes two projects – project 1 is the foundations and earthwork portion of the work and project 2 is the equipment and canopies portion of the work. The Phase III package included the following nineteen campuses:

The District’s Purchasing Department issued a request for proposals with notification sent to local contractors, area chambers of commerce and contractors on a list supplied by the DFW Minority Business Council. Notice of the request for proposals was also advertised in accordance with state law. Proposals were received from four contractors:

- J Squared Construction Services, LLC
- Reeder Concrete
- MART, Inc.
- Reeder General Contractors

Proposals received from the bidders were evaluated on lowest qualified price, representing “best value” to the District. District staff worked with J Squared Construction Services, LLC (JSCS), the lowest qualified bidder, to ensure the intended project scope is being addressed and identify opportunities to reduce the proposed cost.

The total project budget for Phase III of the Playground Renovation and Improvements – Foundations and Earthwork project is \$3,250,000. JSCS offered a proposal amount of \$4,153,103 for the project. The proposed construction contract is over the estimated construction budget by \$885,103 (\$46,584.37 per campus). The overage will be funded from project contingency funds within each individual campus bond project budget.

The engineer's letter of recommendation for contract award for Phase III Playground Renovation and Improvements – Foundations and Earthwork Project is attached.

Pending approval of CSP, work on this project will begin in April of 2023 with final completion expected in December of 2023.

The District approved the Bowie & Seguin HS Football Field and Track Surface Replacement Project as a part of the 2019 Bond program. The District requested proposals and sent notice of the request for Competitive Sealed Proposal (CSP) to local contractors, area chambers' of commerce and contractors on a list supplied by the DFW Minority Business Council. Notice of the request for CSP was also advertised in accordance with state law. Proposals were received from two contractors:

Hellas Construction  
 Paragon Sports Constructors

Competitive Sealed Proposals received from the proposers were evaluated based on criteria published in the CSP document:

Price	35%
Qualifications	55%
HUB Participation	10%

An evaluation committee consisting of the AISD Director of Facility Planning and Construction, AISD Senior Project Manager, two AISD Project Managers, a representative of VLK Architects and a representative of Glenn Engineering determined Hellas Construction (Hellas) to represent "Best Value" to the District with the highest point total of the two proposers at 86.32 points.

The total project construction budget for the Bowie HS & Seguin HS Football Field and Track Surface Replacement Project is \$3,000,000. Hellas offered a CSP amount of \$2,203,785 for the project. The proposed construction contract is \$796,215 less than the total project construction budget. Based on this evaluation, District Administration recommends accepting the Competitive Sealed Proposal from Hellas Construction for a total contract amount of \$2,203,785.

The Architect's letter of recommendation for the Bowie HS and Seguin HS Football Field and Track Surface Replacement Project is attached. Pending approval by the Board of Trustees, work on this project will begin in May 2023 with final completion expected at the end of August 2023.

President Fowler adjourned to closed meeting at 5:06 p.m. pursuant to Sections 551.071 through 551.084 and 551.089 of the Texas Government Code in accordance with the Texas Open Meetings Act for the topics set forth on the agenda.

RECONVENE INTO OPEN SESSION: Board Room

President Fowler reconvened the Board into the open meeting at 6:41 p.m. with six trustees present. Trustee Reich was not present at this point in the meeting.

OPENING CEREMONY:

John Hibbs led the audience in the pledges. Mrs. Fowler called for a moment of silence.

PROGRAM AND/OR PRESENTATION:

President Fowler announced that she was moving part of her Board report to the beginning of the meeting. She invited Andy Nguyen and members of the Vietnamese American Community of Tarrant County Board to the podium for a presentation. Mr. Nguyen presented Dr. Cavazos with a plaque, in honor of his upcoming retirement, thanking him for his years of service and support of the Vietnamese American community.

A. Student Performance by Corey Fine Arts and Dual Language Academy Piano Musicians

Executive Director of Communications and Marketing Anita Foster introduced the Corey Fine Arts and Dual Language Academy musicians. Students at Corey Academy are fortunate to learn a variety of fine arts, including piano. These first graders have been learning different piano pieces and learning about the composers who wrote them. This month they have been learning about Johann Sebastian Bach, whose birthday happens to be in March. B. Students of the Month

David Jarvis spoke regarding AISD's lack of transparency and AISD policy.

SUPERINTENDENT'S REPORT:

Superintendent Cavazos congratulated all of the Special Olympians in the Arlington ISD. Recently the district sent sixty-seven students from seven teams to Austin for the Special Olympics State Volleyball championship. That is the most the district has ever sent for this event. All seven AISD teams placed in the top four at state, with one winning gold, three others taking silver, two winning bronze and another finishing fourth. Dr. Cavazos also thanked all the chaperones who helped on the trip, and everyone involved in the sendoff at Seguin High School for these outstanding students.

Dr. Cavazos congratulated Seguin High School sophomore Paul Nguyen. Paul was the lone Arlington ISD swimmer to qualify for the state meet in Austin. Paul competed in the fifty-yard freestyle at state, and he is a sophomore. Paul's exploits were noticed by the City as he was honored as the City of Arlington student-athlete of the month for February.

Twenty-three wrestlers earned congratulations as they qualified for the state wrestling meet from four schools. The Martin High School boys just missed out on the Class 6A title, finishing second in state with three state champions. A Martin High School student also won a state title on the girls' side.

Black History month wrapped up earlier this week and Dr. Cavazos commended everyone throughout the district for all the outstanding events and activities throughout the month. Whether it was the annual Black History event at Sam Houston High School, the choir performance at Butler Elementary, the spotlight on historically Black colleges at Patrick Elementary, or the virtual trip to Ghana that students at Atherton Elementary took, AISD schools found great ways to put the spotlight on different aspects of the Black community in February.

Dr. Cavazos commended Blanton Elementary, Hale Elementary and Miller Elementary for being recognized as distinguished STEM labs in the Arlington ISD. Dr. Cavazos visited the three schools and surprised the STEM lab managers at each of them. They were honored for high student and teacher usage of the labs for their STEM instruction that aligns with state standards. Each of the schools also received a \$300 check for being the three highest-scoring campuses.

Finally, Dr. Cavazos congratulated AISD's communications and marketing department for their success at the recent Texas School Public Relations Association annual conference. The team collected seventeen gold awards for their work and won four best in show honors at the TSPRA conference for their Arabic flyer, convocation video, prekindergarten marketing campaign, and transfer campaign. The district was also a finalist for a crystal commendation for its prekindergarten marketing efforts. Dr. Cavazos commended Anita Foster and her staff for their work.

#### SCHOOL BOARD'S REPORT:

Mrs. McMurrough reported that on February 22-23, 2023 the superintendent, board members and some staff members traveled to Austin to advocate with legislators for the future of public education. She commended everyone for their efforts and thanked the staff that worked behind the scenes to make the visits possible. She asked everyone to reach out to their legislators now regarding important topics. The AISD legislative agenda is on the website, [www.aisd.net/district/legislative-agenda](http://www.aisd.net/district/legislative-agenda). She also asked that everyone stay informed on issues facing public education.

Mrs. Mays reported that March is Women's History Month. She acknowledged the theme, celebrating women who tell stories. Some of the best stories women tell are about themselves, how they are feeling and how they are recovering. She encouraged everyone to go read a book, perhaps a biography by a woman about herself. Mrs. Mays' best advice for women is to give yourself grace. She shared a quote from Maya Angelou, "You may encounter many defeats, but you must not be defeated. In fact, it may be necessary to encounter the defeats, so you can know who you are, what you can rise from, how you can still come out of it."

Mrs. Fowler thanked Mrs. McMurrough and Mrs. Mays for being strong, phenomenal women.

Secretary McMurrough had no items to report.



THIS CONTRACT for election services is made by and between the Tarrant County Elections Administrator and the following political subdivisions located entirely or partially inside the boundaries of Tarrant County:

The Tarrant County Elections Administrator and the political subdivisions mentioned above may be collectively referred to as "Parties" or individually as a "Party".

This Contract is made pursuant to Texas Election Code Sections 31.092 and 271.002 – 271.004, if applicable, and Texas Education Code Section 11.0581 for a joint May 6, 2023 election to be administered by the undersigned Tarrant County Elections Administrator, hereinafter referred to as "Elections Administrator." This term includes the Assistant Elections Administrator in the Elections Administrator's absence or disability.

**RECITALS**

Each Participating Authority listed above plans to hold a general and/or special election on May 6, 2023. If a run-off election or a repeat election is necessary because of legal action, the date of that election will be June 10, 2023.

The County owns an electronic voting system, the Hart InterCivic Verity Voting System (Version 2.4), which has been duly approved by the Secretary of State pursuant to Texas Election Code Chapter 122, as amended, and is compliant with the accessibility requirements for persons with disabilities set forth by Texas Election Code Section 61.012. The contracting political subdivisions, also known interchangeably as "Entities" or "Participating Authority(ies)", desire to use the County's electronic voting system and to compensate the County for such use and to share in certain other expenses

connected with joint elections in accordance with the applicable provisions of Chapters 31 and 271 of the Texas Election Code, as amended. The entity desires to contract for the voting system as described, in tandem with the County's elections services through the Elections Administrator's office, and to compensate the County for such use and to share in other expenses connected with joint elections in accordance with the applicable provisions of law and of this contract.

NOW THEREFORE, in consideration of the mutual covenants, agreements, and benefits to the Parties, IT IS AGREED as follows:

### **I. ADMINISTRATION**

The Parties agree to hold a joint election with each other ("Joint Election") in accordance with Chapter 271 of the Texas Election Code and this Agreement. The Tarrant County Elections Administrator shall coordinate, supervise, and handle all aspects of administering the Joint Election as provided in this Agreement. Each Participating Authority agrees to pay the Tarrant County Elections Administrator for equipment, supplies, services, and administrative costs as provided in this Agreement. The Tarrant County Elections Administrator shall serve as the administrator for the Joint Election; however, each Participating Authority shall remain responsible for the decisions and actions of its officers necessary for the lawful conduct of its election. The Elections Administrator shall provide advisory services in connection with decisions to be made and actions to be taken by the officers of each Participating Authority as necessary. Legal advice to or legal representation of the Entities/political subdivisions/Participating Authorities by the Election Administrator's office or lawyers who advise or represent the Election Administrator is not included herewith; each Entity should consult with its own counsel for any legal issues that arise, or with the Texas Secretary of State, as appropriate.

It is understood that other political subdivisions may wish to participate in the use of the County's electronic voting system and polling places, and it is agreed that the Elections Administrator may enter into other contracts for election services for those purposes on terms and conditions generally similar to those set forth in this Contract. In such cases, costs shall be pro-rated among the participants according to Section XI of this Contract.

Each Participating Authority agrees to adopt the adopt the Verity Voting System v. 2.5, from HART InterCivic, as the Voting System for this election, so that it may be used, in accordance with the terms and conditions specified in the certification order issued by the Texas Secretary of State, for all forms of voting, including election day voting at polling locations, early voting in person, early voting by mail, and provisional voting.

At each polling location, joint participants shall share voting equipment and supplies to the extent possible. The Participating Authorities shall share a mutual ballot in those polling places where jurisdictions overlap. However, in no instance shall a voter be permitted to receive a ballot containing an office or proposition stating a measure on which the voter is ineligible to vote. Multiple ballot styles shall be available in those shared polling places where jurisdictions do not overlap.

### **II. LEGAL DOCUMENTS**

Each Participating Authority shall be responsible for the preparation, adoption, and publication of all required election orders, resolutions, notices, and any other pertinent documents required by the Texas Election Code and/or the Participating Authority's governing body, charter, or ordinances, except that the Elections Administrator shall be responsible for the preparation and publication of all voting system testing notices that are required by the Texas Election Code.

Preparation of the necessary materials for notices and the official ballot shall be the responsibility of each Participating Authority, including translation to languages other than English, including (but not necessarily limited to), as required by law, Spanish and Vietnamese. Each Participating Authority shall provide a copy of their respective election orders and notices to the Tarrant County Elections Administrator.

### **III. VOTING LOCATIONS**

The Elections Administrator shall select and arrange for the use of and payment for all Election Day voting locations. Voting locations will be, whenever possible, the usual voting location for each election precinct in elections conducted by each participating city, and shall be compliant with the accessibility requirements established by Election Code Section 43.034 and the Americans with Disabilities Act (ADA). The proposed voting locations are listed in Attachment A of this Agreement. In the event that a voting location is not available or appropriate, the Elections Administrator will arrange for

use of an alternate location with the approval of the affected Participating Authorities. The Elections Administrator shall notify the Participating Authorities of any changes from the locations listed in Attachment A.

If polling places for the May 6, 2023 joint election are different from the polling place(s) used by a Participating Authority in its most recent election, the authority agrees to post a notice no later than May 6, 2023 at the entrance to any previous polling places in the jurisdiction stating that the polling location has changed and stating the political subdivision's polling place names and addresses in effect for the May 6, 2023 election. This notice shall be written in both the English, Spanish, and Vietnamese languages.

#### **IV. ELECTION JUDGES, CLERKS, AND OTHER ELECTION PERSONNEL**

Tarrant County shall be responsible for the appointment of the presiding judge and alternate judge for each polling location. The Elections Administrator shall make emergency appointments of election officials if necessary.

Upon request by the Elections Administrator, each Participating Authority agrees to assist in recruiting polling place officials who are bilingual [(fluent in both English and Spanish) and (fluent in both English and Vietnamese)]. In compliance with the Federal Voting Rights Act of 1965, as amended, each polling place containing more than 5% Hispanic or Vietnamese population as determined by the most recent Census used for such determinations shall have one or more election officials who are fluent in both English and Spanish, or both English and Vietnamese, as applicable. If a presiding judge is not bilingual, and is unable to appoint a bilingual clerk, the Elections Administrator may recommend a bilingual worker for the polling place. If the Elections Administrator is unable to recommend or recruit a bilingual worker, the Participating Authority or authorities served by that polling place shall be responsible for recruiting a bilingual worker for interpretation and translation services as needed at that polling place.

The Elections Administrator shall notify all election judges of the eligibility requirements of Subchapter C of Chapter 32 of the Texas Election Code and will take the necessary steps to ensure that all election judges appointed for the Joint Election are eligible to serve.

The Elections Administrator shall arrange for the training and compensation of all election judges and clerks. The Elections Administrator shall arrange for the date, time, and place for presiding election judges to pick up their election supplies. Each presiding election judge will be sent a letter from the Elections Administrator notifying the judge of the appointment, the time and location of training and distribution of election supplies, and the number of election clerks that the presiding judge may appoint.

Each election judge and clerk will receive compensation at the hourly rate established by Tarrant County pursuant to Texas Election Code Section 32.091 or other law applicable to compensation for the election-related work. The election judge will receive an additional sum of \$25.00 for picking up the election supplies prior to Election Day and for returning the supplies and equipment to the central counting station after the polls close.

Election judges and clerks who attend voting equipment training and/or procedures training shall be compensated at the same hourly rate that they are to be paid on Election Day.

The Elections Administrator may employ other personnel necessary for the proper administration of the election, including such part-time help as is necessary to prepare for the election, to ensure the timely delivery of supplies during early voting and on Election Day, and for the efficient tabulation of ballots at the central counting station. Part-time personnel working as members of the Early Voting Ballot Board and/or central counting station on election night will be compensated at the hourly rate set by Tarrant County in accordance with Election Code Sections 87.005, 127.004, and 127.006.

#### **V. PREPARATION OF SUPPLIES AND VOTING EQUIPMENT**

The Elections Administrator shall arrange for all election supplies and voting equipment including, but not limited to, official ballots, sample ballots, voter registration lists, and all forms, signs, maps and other materials used by the election judges at the voting locations. The Elections Administrator shall ensure availability of tables and chairs at each polling place and shall procure rented tables and chairs for those polling places that do not have tables and/or chairs.

The Elections Administrator shall provide the necessary voter registration information, maps, instructions, and other information needed to enable the election judges in the voting locations that have more than one ballot style to conduct a proper election.

Each Participating Authority shall furnish the Elections Administrator a list of candidates and/or propositions showing the order and the exact manner in which the candidate names and/or proposition(s) are to appear on the official ballot (including titles and text in each language in which the authority's ballot is to be printed). Each Participating Authority shall be responsible for proofreading and approving the ballot insofar as it pertains to that authority's candidates and/or propositions.

The joint election ballots that contain ballot content for more than one joint participant because of overlapping territory shall be arranged in the following order: Independent School District, City, Water District(s), College District, and other political subdivisions.

The Elections Administrator shall be responsible for the preparation, testing, and delivery of the voting equipment for the election, as required by the Election Code.

The Elections Administrator shall conduct criminal background checks on relevant employees upon hiring as required by Election Code Section 129.051(g).

## **VI. EARLY VOTING**

The Participating Authorities agree to conduct joint early voting and to appoint the Election Administrator as the Early Voting Clerk in accordance with Sections 31.097 and 271.006 of the Texas Election Code. Each Participating Authority agrees to appoint the Elections Administrator's permanent county employees as deputy early voting clerks. The Participating Authorities further agree that the Elections Administrator may appoint other deputy early voting clerks to assist in the conduct of early voting as necessary, and that these additional deputy early voting clerks shall be compensated at an hourly rate set by Tarrant County pursuant to Section 83.052 of the Texas Election Code. Deputy early voting clerks who are permanent employees of the Tarrant County Elections Administrator or any Participating Authority shall serve in that capacity without additional compensation.

Early Voting by personal appearance will be held at the locations, dates, and times listed in Attachment "B" of this document. Any qualified voter of the Joint Election may vote early by personal appearance at any of the joint early voting locations.

As Early Voting Clerk, the Elections Administrator shall receive applications for early voting ballots to be voted by mail in accordance with Chapters 31 and 86 of the Texas Election Code. Any requests for early voting ballots to be voted by mail received by the Participating Authorities shall be forwarded immediately by fax or courier to the Elections Administrator for processing. The Elections Administrator will be responsible for managing the Annual Ballot by Mail voters for whom the Elections Administrator has received an Application for Ballot by Mail, including maintaining and making available the early voting roster information in conformance with Section 87.121 of the Texas Election Code. Upon request of a participating authority, the Early Voting Clerk will promptly make all information contained within the early voting roster available for inspection by the participating authority, including the information maintained under Section 87.121(f). The Participating Authorities understand that, as specified in section 87.121, information on the roster for a person to whom an early voting mail ballot has been sent is not available for public inspection, except to the voter seeking to verify that the information pertaining to the voter is accurate, until the first business day after election day.

In addition to making the information on the roster for a person who votes an early voting ballot by personal appearance available for public inspection not later than the beginning of the regular business hours on the day after the date the information is entered on the roster, the Elections Administrator shall post on the county website each Participating Authority's early voting report on a daily basis and a cumulative final early voting report following the close of early voting. In accordance with Section 87.121(g) of the Election Code, the daily reports showing the previous day's early voting activity will be posted to the county website no later than 10:00 AM each business day.

## **VII. EARLY VOTING BALLOT BOARD AND SIGNATURE VERIFICATION COMMITTEE**

Tarrant County shall appoint an Early Voting Ballot Board (EVBB) to process early voting results from the Joint Election. The Presiding Judge, with the assistance of the Elections Administrator, shall appoint two or more additional members to constitute the EVBB. The Elections Administrator shall determine the number of EVBB members required to efficiently process the early voting ballots.

The Elections Administrator shall determine whether a Signature Verification Committee is necessary, and if so, shall appoint the members.

### **VIII. CENTRAL COUNTING STATION AND ELECTION RETURNS**

The Elections Administrator shall be responsible for establishing and operating the central and remote counting stations to receive and tabulate the voted ballots in accordance with the provisions of the Texas Election Code and of this Agreement.

The Participating Authorities hereby, in accordance with Section 127.002, 127.003, and 127.005 of the Texas Election Code, appoint the following central counting station officials:

Counting Station Manager:	Heider Garcia, Elections Administrator
Tabulation Supervisor:	Troy Havard, Assistant Elections Administrator
Presiding Judge:	David Lambertsen

The Counting Station Manager or his/her representative shall deliver timely cumulative reports of the election results as precinct report to the central and remote counting stations and are tabulated. The Counting Station Manager shall be responsible for releasing unofficial cumulative totals and precinct returns from the election to the joint participants, candidates, press, and general public by distribution of hard copies at the central counting station or by electronic distribution and by posting to the Tarrant County web site. To ensure the accuracy of reported election returns, results printed on the tapes produced by Tarrant County's voting equipment will not be released to the Participating Authorities at the remote collection sites or by phone from individual polling locations.

The Elections Administrator will prepare the unofficial canvass reports that are necessary for compliance with Election Code Section 67.004 after all precincts have been counted and will deliver a copy of these unofficial canvass reports to each Participating Authority as soon as possible after all returns have been tabulated. Each Participating Authority shall be responsible for the official canvass of its respective election(s).

The Elections Administrator will prepare the electronic precinct-by-precinct results reports for uploading to the Secretary of State as required by Section 67.017 of the Election Code. The Elections Administrator agrees to upload these reports for each Participating Authority unless requested otherwise.

The Elections Administrator shall be responsible for conducting the post-election manual recount required by Section 127.201 of the Texas Election Code unless a waiver is granted by the Secretary of State. Notification and copies of the recount, if waiver is denied, will be provided to each Participating Authority and the Secretary of State's Office.

### **IX. PARTICIPATING AUTHORITIES WITH TERRITORY OUTSIDE TARRANT COUNTY**

Each Participating Authority with territory containing population outside Tarrant County agrees that the Elections Administrator shall administer only the Tarrant County portion of those elections.

### **X. RUNOFF ELECTIONS**

Each Participating Authority shall have the option of extending the terms of this Agreement through its runoff election, if applicable. In the event of such runoff election, the terms of this Agreement shall automatically extend unless the Participating Authority notifies the Elections Administrator in writing within three (3) business days after the original election, not counting election day.

Each Participating Authority shall reserve the right to reduce the number of early voting locations and/or Election Day voting locations in a runoff election.

Each Participating Authority agrees to order any runoff election(s) at its meeting for canvassing the votes from the May 6, 2023 election.

Each Participating Authority eligible to hold runoff elections agrees that the date of the runoff election, if necessary, shall be June 10, 2023.

### **XI. ELECTION EXPENSES AND ALLOCATION OF COSTS**

The Participating Authorities agree to share the costs of administering the Joint Election. Allocation of costs, unless specifically stated otherwise, is mutually agreed to be shared according to a formula which is based on the average cost per Election Day polling place (unit cost) as determined by adding together the overall expenses and dividing the expenses equally among the total number of polling places. Costs for polling places shared by more than one Participating Authority shall be pro-rated equally among the participants utilizing that polling place.

It is agreed that charges for Election Day judges and clerks and Election Day polling place rental fees shall be directly charged to the appropriate Participating Authority rather than averaging those costs among all participants.

Costs for Voting by Personal Appearance shall be allocated based upon the actual costs associated with each voting site. Each Participating Authority shall be responsible for a pro-rata portion of the actual costs associated with the voting sites located within their jurisdiction. Participating authorities that do not have a voting site within their jurisdiction shall pay a pro-rata portion of the nearest regular early voting site.

Costs for Early Voting by Mail shall be allocated according to the actual number of ballots mailed to each Participating Authority's voters.

Participating Authorities having the majority of their voters in another county, and fewer than 500 registered voters in Tarrant County, and that do not have an Election Day polling place or early voting site within their jurisdiction shall pay a flat fee of \$400 for election expenses.

Each Participating Authority agrees to pay the Tarrant County Elections Administrator an administrative fee equal to ten percent (10%) of its total billable costs (but not less than \$ 75.00) in accordance with Section 31.100(d) of the Texas Election Code.

The Tarrant County Elections Administrator shall deposit all funds payable under this Contract into the appropriate fund(s) within the county treasury in accordance with Election Code Section 31.100.

#### **Cost schedule and invoicing.**

A cost estimate for the services, equipment, and supplies provided by the Elections Administrator for the election and the runoff election is shown below and in section XII of this Agreement. This cost estimate shall serve as the cost schedule agreed upon by the contracting Parties, as referenced in Section 31.093(a), Texas Election Code.

As soon as reasonably possible after the election or the runoff election, the Elections Administrator will submit an itemized invoice to each Party: (i) for the actual expenses he/she incurred as described above and (ii) for the Elections Administrator's fee as described above. The invoice shall reflect any advance monies paid and any direct payments made. The Elections Administrator will use his/her best efforts to submit the invoice within thirty (30) days after the election or within ten (10) days after the runoff election.

The Elections Administrator's invoice shall be due and payable by each Party to the address set forth in the invoice within thirty (30) days after its receipt by the Party. If the Party disputes any portion of the invoice, the Party shall notify the Elections Administrator in writing within such thirty-day period, or the invoice will be presumed to be a true and accurate rendering of the amount that is due.

### **XII. COST ESTIMATES AND DEPOSIT OF FUNDS**

The total estimated obligation for each Participating Authority under the terms of this Agreement is listed below. Each Participating Authority agrees to pay the Tarrant County Elections Administrator a deposit of approximately 75% of this estimated obligation within fifteen (15) days after execution of this Agreement. The exact amount of each Participating Authority's obligation under the terms of this Agreement shall be calculated after the May 6, 2023 election (or runoff election, if applicable), and if the amount of an authority's total obligation exceeds the amount deposited, the authority shall pay to the Elections Administrator the balance due within thirty (30) days after the receipt of the final invoice from the Elections Administrator. However, if the amount of the authority's total obligation is less than the amount deposited, the Elections Administrator shall refund to the authority the excess amount paid within thirty (30) days after the final costs are calculated.

The total estimated obligation and required deposit for each Participating Authority under the terms of this Agreement shall be as follows:

### XIII. WITHDRAWAL FROM CONTRACT DUE TO CANCELLATION OF ELECTION

Any Participating Authority may withdraw from this Agreement and the Joint Election should it cancel its election in accordance with Sections 2.051 - 2.053 of the Texas Election Code. The withdrawing authority is fully liable for any expenses incurred by the Tarrant County Elections Administrator on behalf of the authority plus an administrative fee of ten percent (10%) of such expenses (but not less than \$ 75.00). Any monies deposited with the Elections Administrator by the withdrawing authority shall be refunded, minus the aforementioned expenses and administrative fee if applicable.

It is agreed that any of the joint election early voting sites that are not within the boundaries of one or more of the remaining Participating Authorities, with the exception of the early voting site located at the Tarrant County Elections Center, may be dropped from the joint election unless one or more of the remaining Participating Authorities agree to fully fund such site(s). In the event that any early voting site is eliminated under this section, an addendum to the Contract shall be provided to the remaining participants within five days after notification of all intents to withdraw have been received by the Elections Administrator.

### XIV. RECORDS OF THE ELECTION

The Elections Administrator is hereby appointed general custodian of the voted ballots and all records of the Joint Election as authorized by Section 271.010 of the Texas Election Code.

Access to the election records shall be available to each Participating Authority as well as to the public in accordance with applicable provisions of the Texas Election Code and the Texas Public Information Act. The election records shall be stored at the offices of the Elections Administrator or at an alternate facility used for storage of county records. The Elections Administrator shall ensure that the records are maintained in an orderly manner so that the records are clearly identifiable and retrievable.

Records of the election shall be retained and disposed of in accordance with the provisions of Section 66.058 of the Texas Election Code. If records of the election are involved in any pending election contest, investigation, litigation, or public information request, the Elections Administrator shall maintain the records until final resolution or until final judgment, whichever is applicable. It is the responsibility of each Participating Authority to bring to the attention of the Elections Administrator any notice of pending election contest, investigation, litigation or public information request which may be filed with the Participating Authority.

### XV. RECOUNTS

A recount may be obtained as provided by Title 13 of the Texas Election Code. By signing this document, the presiding officer of the contracting Participating Authority agrees that any recount shall take place at the offices of the Elections Administrator, and that the Elections Administrator shall serve as Recount Supervisor and the Participating Authority's official or employee who performs the duties of a secretary under the Texas Election Code shall serve as Recount Coordinator.

The Elections Administrator agrees to provide advisory services to each Participating Authority as necessary to conduct a proper recount.

### XVI. MISCELLANEOUS PROVISIONS

1. It is understood that to the extent space is available, other districts and political subdivisions may wish to participate in the use of the County's election equipment and voting places, and it is agreed that the Elections Administrator may contract with such other districts or political subdivisions for such purposes and that in such event there may be an adjustment of the pro-rata share to be paid to the County by the Participating Authorities.
2. The Elections Administrator shall file copies of this document with the Tarrant County Judge and the Tarrant County Auditor in accordance with Section 31.099 of the Texas Election Code.
3. Nothing in this Contract prevents any Party from taking appropriate legal action against any other Party and/or other election personnel for a breach of this Contract or a violation of the Texas Election Code.
4. This Agreement shall be construed under and in accord with the laws of the State of Texas, and all obligations of the Parties created hereunder are performable in Tarrant County, Texas.
5. In the event that one or more of the provisions contained in this Agreement shall for any reason be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision hereof and this Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein.
6. All Parties shall comply with all applicable laws, ordinances, and codes of the State of Texas, all local governments, and any other entities with local jurisdiction.
7. The waiver by any party of a breach of any provision of this Agreement shall not operate as or be construed as a waiver of any subsequent breach.
8. Any Amendments of this Agreement shall be of no effect unless in writing and signed by all Parties hereto.
9. In the event of an emergency or unforeseen event on Election Day that requires adjustment to these procedures to keep the election operating in a timely, fair, and accessible manner, Elections Administrator may make such adjustments to the procedures herein as the circumstances require.

**Purpose:**

To consider the approval to request a waiver from the Texas Education Agency (TEA) for Missed School Days at Crow Elementary and at Lamar High School.

**Background:**

The Texas Education Agency provides a waiver opportunity for Local Education Agencies (LEA) for weather conditions, health issues or safety related issues.

**CROW:** On March 3, 2023 Crow Elementary and the surrounding neighborhood lost all power due to an extensive storm on the previous night. ONCOR could not provide an estimated time to have the power restored at the campus and the District could not safely open the school without power, so school was cancelled that day. Power was restored late in the afternoon.

**LAMAR:** On March 20, 2023 prior to the opening of school, there was a shooting on the outside grounds of Lamar High School. One student was hit by gun fire and subsequently lost his life. Another student was hit with shrapnel but did not have life-threatening injuries. Due to the safety issues associated with this event and the time needed to address the school community, school was cancelled for students on March 20 and March 21. School resumed on March 22, 2023.

**Recommendation:**

The administration recommends the Board approve the submission of Missed School Days Waiver for Crow Elementary on March 3, 2023 and Lamar High School on March 20-21, 2023 to the Texas Education Agency.





This letter is to inform you of certain unforeseen conditions related to the construction schedule for the Arlington ISD Thornton Elementary School Replacement Project. We have thoroughly reviewed the Notice of Delay letter received by Pogue Construction dated February 23, 2023. There are two items that were unanticipated delays as listed below.

- Item 1: Electrical service to the building was ready to be installed by Pogue Construction on January 17, 2023. There have been delays by Oncor on delivery as well as setting the incorrect transformer size. Pogue Construction has been working closely with Oncor to correct the transformer issue and energize the building. Pogue is requesting 37 additional days due to this delay.
  
- Item 2: Weather caused delays in multiple critical path items such as: earthwork, concrete, utilities, grade beams, steel, sheathing, masonry, MEP, roofing and grading. Pogue is requesting 40 additional days due to this delay.



**INTERLOCAL AGREEMENT BETWEEN THE CITY OF ARLINGTON AND  
ARLINGTON INDEPENDENT SCHOOL DISTRICT**

THE STATE OF TEXAS  
COUNTY OF TARRANT

This Interlocal Agreement (this “Agreement”) is entered into by and between the **CITY OF ARLINGTON, TEXAS**, a municipal corporation (hereinafter referred to as “CITY”); and **ARLINGTON INDEPENDENT SCHOOL DISTRICT** (hereinafter referred to as “AISD”).

WHEREAS, the Texas State Legislature has authorized the formulation of Interlocal Cooperation Agreements between and among governmental entities pursuant to the Interlocal Cooperation Act, Chapter 791 of the Texas Government Code, as amended; and

WHEREAS, AISD desires to provide a certain subset of AISD students with a transportation option that allows them to get to and from school and participate in after school activities; and

WHEREAS, CITY currently operates an innovative on-demand ridesharing public transportation service, Via; and

WHEREAS, CITY received federal funding for Via operations through the North Central Texas Council of Governments (hereinafter referred to as “NCTCOG”) on the condition that it fund a student transportation program with AISD, which allows a specific subset of AISD students access to Via, without paying the per ride fee (hereinafter referred to as “Ride Fare”); and

WHEREAS, AISD received federal grant funding to aid homeless children and youth; and

WHEREAS, CITY and AISD are currently parties to an Interlocal Agreement, approved by City Council on November 30, 2021, whereby CITY provides AISD students attending the Arlington Collegiate Campus at the Tarrant County College South East Campus and AISD students attending the Arlington College and Career High School access to Via, without paying the Ride Fare; and

WHEREAS, CITY and AISD desire to enter into an additional Interlocal Agreement for deployment of a new student transportation program to serve students in AISD’s Student Outreach Services program (hereinafter called the “SOS Program”); and

WHEREAS, the SOS Program serves a public purpose by providing transportation to school and other activities for a vulnerable student population in the City of Arlington; and

WHEREAS, it is mutually advantageous to both parties to enter into the arrangement evidenced by this Agreement; and

WHEREAS, all funds expended by the parties for governmental functions will be from funds legally available to the parties; NOW THEREFORE:

In consideration of the covenants and agreements hereinafter contained and subject to the terms and conditions hereinafter stated, the parties hereto do mutually agree as follows:

**I.**  
**RECITALS**

The recitals set forth above are true and correct in all material respects and incorporated herein for all purposes.

**II.**  
**SCOPE OF SERVICES**

CITY shall provide the services as are necessary to deploy the SOS PROGRAM, including the tasks enumerated in Exhibit "A" Scope of Project, attached hereto and incorporated herein by reference and made a part hereof as if written word for word. AISD shall monitor the SOS PROGRAM, ensuring students are appropriately utilizing the SOS PROGRAM by following all terms and conditions of the SOS PROGRAM. AISD shall also provide CITY with monthly reports, and shall complete other tasks and responsibilities enumerated in Exhibit "A".

**III.**  
**TERM**

This Agreement shall commence on February 16, 2023 (the "Effective Date"), and shall continue for a period of 12 months, unless terminated earlier in accordance with the terms of this Agreement. This Agreement may be extended for a period not to exceed one (1) additional one (1) year period upon approval by the CITY and AISD.

**IV.**  
**TERMINATION**

This Agreement may be canceled or terminated at any time by the City or AISD with or without cause by providing the other seven (7) days written notice of such termination. Upon receipt of such notice, all work and labor being performed shall immediately cease, pending final cancellation at the end of such seven (7) day period.

**V.**  
**LOSS OF FUNDING**

Performance by a Contracting Party of its duties and obligations under this Agreement may be dependent upon the appropriation and allotment of funds by that Contracting Party's governing board. If the Contracting Party's governing board fails to allocate the necessary funds, then the Contracting Party that loses funding may terminate this Contract without further duty or obligation under this Contract.

If any of the terms, sections, subsections, sentences, clauses, phrases, provisions, covenants or conditions of this AGREEMENT are for any reason held to be invalid, void or unenforceable, the remainder of the terms, sections, subsections, sentences, clauses, phrases, provisions, covenants, or conditions in this AGREEMENT shall remain in full force and effect and shall in no way be affected, impaired or invalidated.

SCOPE OF PROJECT

**1. Purpose**

The purpose of this SOS Program is to provide rides through Via, the City's On-Demand Ride-Sharing Public Transportation Service, to eligible AISD students at no cost to the student. SOS Program rides are solely for AISD students that are part of the Student Outreach Services program, including homeless students ("Eligible Students"). No other individuals are eligible for free rides under this SOS Program.

**2. Eligible Student Rides, Invoices, and Payment**

CITY shall provide AISD with promotional payment codes (hereinafter referred to as "Promo Codes") to be used by Eligible Students to obtain rides through the Via App in lieu of paying the Ride Fare. Said promo codes shall be one-time use codes, and AISD shall have the right to distribute these promo codes to Eligible Students in accordance with the terms of this Agreement. Each student will be responsible for setting up their own Via account to book rides using the City issued Promo Codes. Promo Codes may be used by Eligible Students any time when Via is operating.

CITY shall provide AISD with two (2) different types of Promo Codes. One set of Promo Codes will be funded with NCTCOG funding received by CITY ("CITY NCTCOG Funding"). AISD will not be invoiced for use of these Promo Codes, except where such Promo Codes are misused, as detailed in Section 3 below.

CITY shall provide one set of Promo Codes to be funded with federal grant funds received by AISD ("AISD Federal Grant Funds"). CITY shall send AISD an invoice directly from CITY's third party service provider for AISD's use of those Promo Codes, and AISD shall pay said invoices directly to the service provider within 30 days from the date of the invoice, in compliance with the Texas Prompt Payment Act. AISD shall be solely responsible for ensuring that AISD Federal Grant Funds are used in accordance with all federal and state laws, and that Promo Codes to be funded with AISD Federal Grant Funds are used by Eligible Students, in accordance with the federal grant requirements.

**3. Compliance and Reporting**

AISD shall be responsible for diligently monitoring employee and student compliance with the SOS Program terms and conditions under this Agreement. AISD will monitor the number of Promo Codes issued to Eligible Students and will ensure that only Eligible Students receive Promo Codes. AISD is responsible for communicating to teachers, staff, and students the SOS Program terms and conditions.

AISD will provide City with monthly reports, to be received by CITY no later than the 15<sup>th</sup> day of the month after the reporting period. For example, AISD will send CITY a monthly report for the month of December to be received by CITY no later than January 15<sup>th</sup>. The monthly report shall include the total number of each type of promo codes given to AISD students, a list of any promo codes previously issued that should be deactivated, and whether any student has abused the SOS Program or used a Promo Code in a way that did not comply with the terms of this Agreement. If AISD determines that a

Promo Code was used in a way that does not comply with the terms of this Agreement, AISD shall include that information in their monthly report, regardless of who used the Promo Code.

City shall notify AISD if it detects or becomes aware of improper use of the Promo Codes issued to AISD students. AISD will notify the individual that was issued the Promo Code and use best efforts to confirm whether such misuse occurred. AISD shall be responsible for paying for any rides that fall outside the scope of this project or were otherwise taken with CITY issued Promo Codes and were not in compliance with this Agreement. If AISD determines that a Promo Code was used in a way that does not comply with the terms of this Agreement, AISD shall reimburse the CITY the full Ride Fare paid by the CITY for the use of that Promo Code. Such payment to CITY shall be made within 30 days after reporting the misuse to the CITY. CITY may disable any Promo Code that the CITY or AISD determines has been used in a way that does not comply with the terms of this Agreement. Any Eligible Student that uses a Promo Code in a way that does not comply with the terms of this agreement, including allowing another individual to use a Promo Code issued to that Eligible Student, shall become ineligible for participation in the Program.

CITY shall receive certain non-proprietary data from Via regarding the SOS Program and use of Promo Codes, which may include the total number of Promo Codes used each month, the total cost of those rides to the City, and other information that may be determined by CITY and VIA. CITY may, at AISD's request, provide that data to AISD.

#### **4. Audit**

CITY shall have the right to audit AISD records to determine compliance with the terms of this Agreement. CITY shall provide AISD with fifteen (15) days written notice of audit. To the extent allowed by Texas law, AISD shall provide CITY with all information the CITY requests regarding this SOS Program, including but not limited to information regarding the distribution and use of City issued Promo Codes.

**Subject:** Consider Approval of First Amendment to Extend the T-Mobile Site Lease for the Cell Tower Located on the Grounds of Shackelford Junior High School

**Purpose:**


To consider approval of a first amendment extension to the original site lease for the T-Mobile cell tower located on the grounds of Shackelford Junior High School. This extension will update the lease terms with regard to the contract ending date and payment to the District.

**Background:**

The original contract was executed by the AISD Board President on June 21, 2007, and expired on October 21, 2022. This extension provides for an initial five (5) year term on the effective date of this first amendment and will automatically extend for four (4) additional five (5) year renewal terms. This agreement would expire in April of 2048. The rate of rental in the agreement is negotiated and agreed to based on current market conditions and the geographic location of the tower. Under the terms of the extension agreement, lease payments will increase at each extension (every 5 years) by 4 percent. The total value of this lease, over the life of the agreement, to the District is approximately \$702,000.

**Recommendation:**

AISD Administration recommends approval of the proposed first amendment to extend the T-Mobile site lease for the cell tower located on the grounds of Shackelford Junior High School.

**SCHOOL CAMERA ACCESS INTERLOCAL AGREEMENT BETWEEN  
THE ARLINGTON INDEPENDENT SCHOOL DISTRICT AND  
THE ARLINGTON POLICE DEPARTMENT**

THIS INTERLOCAL AGREEMENT (hereinafter referred to as "Agreement") is made and entered into by and between the Arlington Independent School District (hereinafter referred to as "AISD" or the "District") and the City of Arlington through the Arlington Police Department (hereinafter referred to as "APD") pursuant to authority granted by and in compliance with the Interlocal Cooperation Act, Chapter 791, Texas Government Code. AISD and APD may be referred to individually as a "Party" or collectively as "Parties."

**RECITALS**

WHEREAS, the District utilizes an audio and visual security camera system ("Security Cameras") to provide a safe educational environment for students and workplace for District employees at its 76 school campuses and 22 facilities; and

WHEREAS, APD is responsible for providing for the safety and welfare of Arlington, Texas residents, including District students and employees at District campuses, administrative buildings, and facilities; and

WHEREAS, AISD and APD share responsibility for school safety and recognize the need for a defined understanding as to the access of AISD's Security Cameras by APD in a way that enhances security and aids law enforcement without unnecessary infringement on student privacy.

NOW, THEREFORE, the Parties agree as follows:

**PURPOSE**

1. The purpose of this Agreement is to establish and maintain the terms under which the APD can access AISD Security Cameras to obtain real-time, tactical intelligence to support the safety of the students, staff, visitors, officers, and public on or near AISD campuses and facilities.

**ACCESS**

2. In accordance with applicable state and federal law, including the Family Educational Rights and Privacy Act ("FERPA") (20 U.S.C. § 1232g; 34 CFR Part 99), AISD will grant APD access to Security Cameras and the AISD video management software ("AISD VMS"), including playback operability, for health and safety emergencies. Such access shall be in response to an articulable nexus to criminal activity or public safety concern and no longer than increments of twenty-four (24) hours at a time.
3. Health and safety emergencies shall include, but are not limited to, an actual, impending, or imminent emergency, such as a natural disaster, a terrorist attack, a campus shooting, hostage-taking, fire, act of terrorism, or health related emergencies (individually and collectively, an "emergency").
4. The Parties acknowledge and agree the totality of the circumstances will be considered to determine if a situation is an emergency.
5. In order to obtain access as provided under this Agreement, APD will access the AISD VMS through an AISD-approved hosting client on devices owned by APD. APD agrees access credentials will be limited to those working in the Arlington Tactical Intelligence Unit (ATIUI) and members of the SWAT executive command and its support team ("authorized staff members"). APD shall provide AISD a list of the names of all authorized staff members and promptly notify AISD of any changes to employment or assignment of the same authorized staff members.

6. APD and AISD will adhere to all Rules and Guidelines concerning state, local and federal laws, to include FERPA, AISD Board Policy, City of Arlington policies and procedures, and APD General Orders and Standard Operating Procedures.
7. APD will not have capability through the AISD VMS to save or export video. Video recording through a personal device, such as a smart phone or similar personal device, of the AISD VMS shall be prohibited. Requests for the release of video recordings for evidentiary purposes must be submitted in writing to the AISD Legal Office.
8. This Agreement is not intended to alter or limit the current access, if any, granted to School Resource Officers under another agreement.

#### **DUTIES OF THE ARLINGTON POLICE DEPARTMENT**

9. Arlington Police Department shall adhere to the following duties:
  - a. Ensure that only authorized staff members are granted access credentials to the AISD VMS system.
  - b. Ensure that APD staff members are not circumventing the agreed upon security measures.
  - c. Ensure that APD staff members are not recording camera footage events on personal devices.
  - d. Log into the system on a regular basis to ensure access is working properly and report any noted system failures to designated AISD staff.
  - e. Immediately report any improper usage of the AISD VMS to designated AISD staff.
10. APD is not expected or intended to access the AISD VMS to routinely monitor in real time the Security Cameras.

#### **DUTIES OF THE AISD**

11. Arlington ISD shall adhere to the following duties:
  - a. Ensure that authorized staff members have access to the AISD VMS as provided under this Agreement.
  - b. Work with APD during times of crises to troubleshoot access issues.
  - c. Provide any necessary training to the APD for AISD VMS access.

#### **TERM AND BREACH**

12. This Agreement shall be in effect for a period of one (1) year beginning on \_\_\_\_\_, 2023 and ending on January 31, 2024. The Parties may extend this Agreement for subsequent one (1) year terms by mutual written agreement at least sixty (60) days before the end of the then term.
13. In the event that a Party believes that another Party has materially breached this Agreement, the non-breaching Party shall give prompt written notice of the alleged breach to the breaching Party. The breaching Party shall have fifteen (15) days to cure the alleged breach from the date it receives written notice from the non-breaching Party. If the breach is not restored within fifteen (15) days, the non-breaching Party may terminate this Agreement. A breach of this Agreement includes, but is not limited to, a violation of the policies and rules of APD or AISD, the making of a misrepresentation or false statement by one of the Parties, or the occurrence of a conflict of interest between the Parties.

#### **GENERAL PROVISIONS**

14. This Agreement may be amended at any time by mutual agreement of the Parties in writing and signed by both Parties.

15. The provisions of this Agreement are severable and the unenforceability of any provision of this Agreement shall not affect the enforceability of any other provisions hereof.
16. This Agreement represents the entire agreement between the Parties. No other agreements, oral or written, have been entered into with respect to the subject matter of this Agreement.
17. Nothing in this Agreement requires that the District take any action not allowed by law. The Parties shall take all necessary steps to ensure that this Agreement does not result in a violation of FPERA.
18. There are no third-party beneficiaries to this Agreement.
19. It is expressly understood and agreed that, in the execution of this Agreement, the Parties do not waive, nor shall be deemed hereby to waive, any immunity or defense that would otherwise be available to it against claims arising in the exercise of governmental powers and functions.


**Subject:** House Bill 3 and District Improvement Plan Progress Monitoring Update

**Purpose:**

To provide the Board with progress update pertaining to House Bill 3 (HB 3) requirements for improvement plans addressing early childhood literacy and mathematics proficiency in alignment with the Board adopted monitoring calendar.

**Background:**

In the spring of 2019, the 86<sup>th</sup> Legislature passed the finance bill, HB 3, which included specific requirements pertaining to goal setting and the progress monitoring process for improved outcomes in early childhood literacy and mathematics, as well as college, career, and military readiness (CCMR). The statute requires school boards to adopt plans that include annual goals for aggregate growth on 3<sup>rd</sup> grade reading and mathematics achievement, annual targets for closing achievement gaps among student groups, targeted professional development for classroom teachers and annual targets for students being served in bilingual and ESL programs. The bill also calls for aggregate annual goals and targets for CCMR readiness as evaluated under the state accountability system's student achievement domain and for each student group articulated in the closing the gaps domain. This discussion item will provide a progress update pertaining to student outcome on the State Interim Assessment 2 (SIA 2) in grades 3-11.
